Regulations Governing Conduct at the Marina Park Swim Beach

WHEREAS, the Marina Park is owned and operated by the Port of Hood River; and

WHEREAS, the Port of Hood River Commission adopted Resolution No. 2008-09-3 approving the Governance Policy for the Port of Hood River on April 7, 2009; and

WHEREAS, the Port's Governance Policy provides that the Commission may approve rules and regulations governing activities on its properties through the formulation and approval of ordinances and resolutions; and

WHEREAS, the Port's Waterfront Recreation Committee recommended that kiteboard access, pumping and drying be allowed from June 1, 2010 to September 30, 2010 at designated areas near the Marina Park Swim Beach on a provisional basis; and

WHEREAS, the Port has sought public input on this recommendation; now, therefore

BE IT RESOLVED that Ordinance 22 shall be modified to include the attached Regulations Governing Conduct at the Marina Park Swim Beach dated June 1, 2010 and shall remain in force until revised or revoked by the Commission or Executive Director.

REGULATION GOVERNING CONDUCT AT MARINA PARK SWIM BEACH

Ordinance 22 regulates conduct on Port land, Port waterways, and Port structures. The following regulation expands, defines and regulates conduct in furtherance of the provisions of the ordinance in the Marina Area known as the Marina Park Swim Beach.

- 1. From June 1, 2010 through September 30, 2010 kiteboard activities near the Marina Swim Beach shall be allowed subject to the following limitations:
 - Kiteboard activities may occur within areas described on the attached diagram approved by the Port Commission on May 18, 2010.
 - Activities are allowed as a provisional use. An evaluation of impacts shall be made continuously by the Port. Kiteboard use may be terminated at any time if conflicts occur, the safety of other users is compromised or the public's use of the Marina Park Swim Beach is diminished.
 - Kiteboard groups are encouraged take an active role in self-policing users to insure that use regulations are followed.
