BE IT RESOLVED that the Board of Commissioners hereby levies the taxes provided for in the budget adopted in Paragraph 1 of this resolution in the aggregate amount of \$23,917.96 and that these taxes are hereby levied upon the assessed value as of 1 A.M. January 1, 1989 on all taxable property within the district.
