WHEREAS, the Urban Renewal Agency members include one representative each from the Hood River City Council, the Hood River City Planning Commission, and the Hood River County Board of Commissioners, two Commissioners from the Port of Hood River, and two citizens-at-large from the City of Hood River;

WHEREAS, the Hood River Urban Renewal Agency has prepared an Urban Renewal Plan (known as the Columbia-Cascade Development Plan) and an accompanying Report on such Plan;

WHEREAS, the purpose of the Columbia-Cascade Development Plan is to eliminate blight and depreciating property values, attract job producing private investments that will improve property values and establish a positive linkage between the Development Area and the Columbia River;

WHEREAS, on August 4, 1987, the Planning Commission of the City of hood River conducted a public hearing on the Columbia-Cascade Development Plan and found that it is in compliance with the City Comprehensive Plan and recommended its approval to the City Council;

WHEREAS, the Columbia-Cascade Development Plan has been prepared consistent with the economic development policies of the Mid-Columbia Economic Development District (MCEDD); and

WHEREAS, the Commissioners of the Port of Hood River support the goals and objectives of the Columbia-Cascade Development Plan;

NOW THEREFORE BASED UPON THE FOREGOING

IT IS HEREBY RESOLVED AND ORDERED by the Port of Hood River Board of Commissioners that the City of Hood River Urban Renewal Agency's Columbia-Cascade Development Plan is approved.
