- 1. BE IT RESOLVED that the Board of Commissioners hereby adopts the budget approved by the budget committee of the PORT OF HOOD RIVER for 1990-91 in the sum of \$6,969,256.00, now on file in the Port office, with the following changes from Diamond Industrial Park to the John Weber Business Park:
 - -- Capital outlay for the Cascade Building reduced \$115,900;
 - --Capital outlay for the John Weber Business Park increased \$225,600 with an increase of \$109,700 in revenue offset from the State Economic Development Department of 50/50 loan and grant.
- 2. BE IT RESOLVED that the Board of Commissioners hereby levies the taxes provided for in the budget adopted in Paragraph 1 of this resolution in the aggregate amount of \$22,766.68 and that these taxes are hereby levied upon the assessed value as of 1 A.M. January 1, 1990 on all taxable property within the district.
